Tender is invited under one bid system for “**Making provision for making Lighting & Power supply arrangement at warehouse (Packing Material Store)**” from reputed parties having adequate technical and Financial background as per following terms and conditions specific to this tender. Interested parties are requested to submit duly filled tender documents fulfilling eligible criteria in sealed envelope addressed to General Manager, IDPL Plant Office, Dundahera, Old Delhi Gurgaon Road, Gurgaon- 122016. Sealed envelope marked with tender ref. no. date of opening, clearly on the covers latest by **11.02.2014 up to 2.00 PM**. The Bid will be opened on the same day at **3.00 P.M.** in the presence tenderers /their representative present at the time of opening of the tender.

Name of work: “Making Provision for Lighting & Power Supply arrangement at Warehouse (Packing Material Store)”

Eligibility Criteria and Terms & Conditions for submission of Tender Bid.

The time for execution and completion of work in stipulated time is the essence of the tender. The maximum time allowed for carrying out the work will be One month from the first day of handing over of the site.

1. The Site for work is situated at IDPL Plant premises and is ready for starting the work.
2. **Tenderers are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting** their tenders.
3. The competent authority reserves to himself the right of accepting the whole or any part of the tenders and the tendered shall be bound to perform the same at the rate quoted.
4. Electrical agency must have ‘A’ class license and must be approved by Chief Electrical Inspector, Haryana and a copy of the certificate should be submitted to IDPL
5. The contractor shall take all Safety Precautions during the constructions as per the safety laws.
6. Any injury to contractor worker is the whole responsibility of the contractor and to be covered under their own provisions of insurance.

7. The contractor shall abide by the labour laws and any other laws applicable on him for carrying out the work.
8. B.O.Q. for various activities is enclosed. The quantity of each item may vary as per site conditions.
9. The material supplied by the party should have proper entry at the plant gate.
10. No extra manpower/facility/machinery will be provided by the company and the work should be carried out under the strict supervision of the company Engineers.
11. ESI, TDS, EPF etc. will be deducted as per rules.
12. Dispute arising out in this connection will be subject to Gurgaon Jurisdiction only
13. All the manpower who will work at our site must be proper entry at the plant gate.
14. All returnable material like use a tools etc should have proper entry at the plant gate and Inspected by site engineer (inward & outward)
15. Tenderer's average monthly turn over should not be less than 7.00 Lakh.

A. Earnest Money Deposit (EMD) to be deposited with quotation

1. The quotation for the tender shall include the cost of material, labour, freight charge and taxes etc.

2. PAYMENT TERMS:-

- i.) 70% of the cost of material will be released on receipt of material at site after due verification by the engineer incharge within 5 working days.
- ii.) 25% of material cost and labour charge will be paid after completion of the entire work.
- iii.) Balance 5% of the material cost will be paid after one month from the date of completion of the work.
- iv.) Party is to state clearly the percentage of material cost and percentage of labour charge involved in the entire work **separately** for making statutory deduction etc.

3. General Terms and Conditions:-

- ⌚ The work shall be carried out as per direction of site engineer incharge.
- ⌚ All the necessary tool, tackles & scaffolding etc, required in execution of work is to be arranged by the party on their own cost.
- ⌚ All the malwa, scrap etc will to be removed from the site work to the near dumping area.
- ⌚ Time of completion of work is one month from the date of issue of work order/ handing over the equipments/site.
- ⌚ **Liquidated damages:-** In case of work is not completed within one month from the date of order then LD will be charged @0.5% of tender value per 15 days, subject to maximum of 5% of full tender value / cost.
