

**AMENDMENT NO. 1**

The following amendment in Tender Document is hereby authorized: -

**I. Clause No. 4.1 (g)**

**Add the following after clause 4.1(g) :-**

For Imported drugs, Printed manufacturer's MRP (if applicable), supplier shall block Printed MRP while supplying the drugs..

**II. Clause 11 METHODOLOGY FOR PLACING ORDERS :-**

(i) The supplier shall supply the Drugs/Medicines at the (CWH), ), Bilaspur ( Gurgaon ) along with copy of Purchase order, copy of test reports and 3 original copies of Invoice, original label and aluminium sheet (if applicable) sample of primary label. No payment will be processed without test reports

(k) It is the duty of the supplier to supply Drugs/Medicines at the CWH Gurgaon or any other place decided by BPPI and supply shall conform to the conditions mentioned in the provisions of tender documents, viz., logo, nomenclature, specification etc.,

((k) It is the duty of the supplier to supply Drugs/Medicines at the (CWH), ), Bilaspur (Gurgaon ) and supply shall conform to the conditions mentioned in the provisions of tender documents, viz., logo, nomenclature, specification etc.,
