The following amendment in Tender Document and NIT is hereby authorized: -

# I. <u>2.ELIGIBILITY CRITERIA</u>

(a) Add the following after clause 2 (a)(ii):-

The Importer should have valid sale license.

(b) Add the following after clause 2 (a)(iii):-

The Marketer should have valid sale license.

In case the bidder is Importer, a certificate from the C.A.(Chartered Accountant) or ICWA that the bidder has Financial capacity to manufacture as per format (ANNEXURE IVA) and deliver the drugs quoted by the firm in the tender as per quantity mentioned in tender during contract period. The certificate should be uploaded along with the technical bid. The original Certificate (ANNEXURE IVA) should be submitted on or before the schedule time and date of technical bid opening.
