#### 1. Invitation for Bid

- 1.1 Bureau of Pharma PSUs of India (BPPI) invites sealed bid from eligible bidders for supply of 1000 nos. Pallets for carrying and storage of Medicines packed in cases in BPPI Godown as per specification mentioned in subsequent para.
- 1.2 Interested eligible bidders may obtain further information from the office Bureau of Pharma PSUs of India, IDPL Corporate Office, Old-Delhi Gurgaon Road, Dundahera, Gurgaon 122016
- 1.3 Tender document may be downloaded from the BPPI website (hard copies of the tender document will not be provided.

## 3. Eligibility of the Bidder

- 3.1 The bidder Should be the manufacturer or authorized dealer/distributors of manufacturer.
- 3.2 The bidder should submit copy of PAN card and latest copty ITR filed.
- 3.3 The bider should submit copy of latest sales tax/VAT returned filed

#### 4. Submission of BID

- 4.1 The contract shall be awarded for pallets as described in specification.
- 4.2 The Price quoted must be indicated as firm and fixed Price in Indian Rupees only as per price schedule (ANNEXURE I).

Any correction/cutting/rewriting in price without counter signature of bidder shall be rejected.

4.3 All duties, taxes and other levies payable by the contractor under the contract shall be

included in the total price.

- 4.4 The rates quoted by the bidder shall include the cost of inland transportation and other incidentals for delivery of the goods to the final destinations, namely BPPI Godown, Gurgaon.
- 4.5 Each bidder shall submit only one quotation.
- 4.6 The bid complete in all respect must be submitted in sealed envelopes at the BPPI's address given below, on or before time and date specified.

#### 5. Bid Security /EMD:

- 5.1 EMD of Rs. 10,000/- (Rupees Ten thousands only in the form of Bankers Cheque/Demand Draft from nationalized bank/Scheduled Bank favouring "Bureau of Pharma Public Sector Undertakings of India ", payable at Gurgaon which is to be submitted with the bid. EMD in any other form like *cheque/cash/postal order* etc. will not be accepted.
- 5.2 Unsuccessful Bidder's bid security will be discharged or returned after completion of the process.
- 5.3 For successful Bidder EMD will be converted into Security Deposit.
- 5.4 Without Bid security/ EMD, the bid shall be rejected.
- 5.5 The bid security may be forfeited under the following conditions:
  - a) If the bidder withdraws its bid during the period of bid validity specified by the bidder on the bid form.
  - b) In case of the successful bidder, if the bidder fails to supply the Stacker:

#### 6. Terms and Conditions:

- 6.1 The goods should be free delivery to consignee at BPPI Godown, Gurgaon.
- The taxes (sales tax/VAT whichever is applicable) and excise duties should clearly mentioned whether the same is included or extra.
- 6.3 The rate quoted should be valid for 60 days from the date of opening of tender.
- 7. **Determination of L1 Bidder.** BPPI will open the bids on the stipulated day in the presence of authorized representatives of the bidders. L1 bidder will be selected on the basis of the TOTAL COST of goods including taxes and duties.
- 8. BPPI reserves right to accept or reject the tender or bid at any stage.
- 9. Late tender bid shall not be considered under any circumstances.
- 10. The supply shall be made within 15 days alternatively indicate the earliest date of

supply.

- 11. **Performance Security**:- The successful bidder shall furnish performance security for 5% of contract value by means of demand draft drawn in favour of "Bureau of Pharma Public Sector Undertakings of India" payable at Delhi/Gurgaon which will be returned after satisfactory completion of warranty period.
- 12. **JURISDICTION** In the event of any dispute arising out of the tender such dispute would subject to the jurisdiction of the Civil Court within the city of Delhi only.

#### 13. Award of contract:-

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract. Further the purchaser reserves right to place order for part quantity or full quantity as per decision of BPPI.

- 14. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 15. For delay in supply of the goods beyond the stipulated period, liquidated damages at 0.5% per week or part thereof of the contract value, subject to a maximum of 10% of the contract value is leviable.
- 16. The successful bidder shall furnish performance security for 5% of contract value by means of demand draft drawn in favour of "Bureau of Pharma Public Sector Undertakings of India" payable at Delhi/Gurgaon which will be returned after satisfactory completion of warranty period
- 17. Payment shall be made within 30 days after supply and submission of bills with certification from BPPI for satisfactory completion of supply.
- 18. The item supplied shall carry a warranty of at least one year from the date of supply.
