3. Bidder **shall not modify the downloaded tender form including price bid template in any manner**. In case any tender form/Price bid template is found to be tampered with/modified in any manner, such bid will be summarily rejected, Bid Security would be forfeited, and bidder is liable to be banned from doing business with BPPI.

5. The detailed terms and conditions have given in tender document. Likely bidders are requested to go through the tender for disposal of expired Drugs (Injections and Capsules) in accordance with requirements stated in the tender documents. Self-attested documents as required in tender document should be submitted offline bid. In absence of above document, the bid will liable to be ignored and not considered.
