3. Bidder **shall not modify the downloaded tender form including price bid template in any manner**. In case any tender form/Price bid template is found to be tampered with/modified in any manner, such bid will be summarily rejected, Bid Security would be forfeited, and bidder is liable to be banned from doing business with BPPI.

4. Bidders are advised to check the *website of BPPI: janaushadhi.gov.in* at least 3 days prior to closing date of submission of tender for any corrigendum, addendum, or amendment to the tender document.

5. The detailed terms and conditions have given in tender document. Likely bidders are requested to go through the tender for disposal of expired drugs (Syrups) in accordance with requirements stated in the tender documents. Self-attested documents as required in tender document should be submitted offline bid. In absence of above document, the bid will liable to be ignored and not considered.

6. **Tender cost:** The tender document can be downloaded free of cost from the website of BPPI: janaushadhi.gov.in.

7. **EMD (Earnest Money Deposit):** EMD of Rs. 1,00,000/- (Rupees One Lakh only) **Demand Draft from nationalized/ Scheduled Bank or National Electronic Fund Transfer (NEFT) in favouring "Bureau of Pharma Public Sector Undertakings of India ", payable at Gurgaon/Delhi which is to be delivered in original to BPPI, New Delhi on or before the date stipulated in bid document.** Name & full address of the bidder may be written at the back of the Demand Draft/Pay Order. EMD in any other form like *cheque/cash/postal order* etc. **will not be accepted. The Bid (in case not exempted for EMD as mentioned in tender document) without EMD shall be summarily rejected.**
