3. **Bidder shall not modify the downloaded tender form including downloaded price bid template in any manner.** In case any tender form/Price bid template is found to be tampered with/modified in any manner, such bid will be summarily rejected, Bid Security would be forfeited, and bidder is liable to be banned from doing business with BPPI.

Self-attested documents as required in tender document should be uploaded while submitting online bid. In absence of above document, the bid will liable to be ignored and not considered.

7. **EMD (Earnest Money Deposit):** EMD of Rs.1000000/- (Rupees Ten Lakh only) as indicated in the form of **Bank Guarantee or National Electronic Fund Transfer (NEFT) or Bankers Cheque or Demand Draft from nationalized/Scheduled Bank favouring “Bureau of Pharma Public Sector Undertakings of India “payable at Delhi/Gurugram** which is to be submitted in original to BPPI on or before stipulated date against ‘Bid opening Date’ as mentioned in the ‘Critical Date Sheet’. Name & full address of the bidder may be written at the back of the Demand Draft/Pay Order. Signed and scanned soft copy of the EMD instrument must be uploaded to the e- Procurement portal along with other bid documents as prescribed in tender document. EMD in any other form like **cheque/cash/postal order** etc. **will not be accepted. The Bid (in case not exempted for EMD as mentioned in tender document) without EMD shall be summarily rejected.**
