Earnest Money Deposit (EMD)/ Bid Security Declaration: The bidder must submit a 'Bid Security Declaration' declaring disqualification/suspension of his bid in case the bid is withdrawn or modified by him during the bid validity period. The format of 'Bid Security Declaration' is available in the Tender Document. 'Bid Security Declaration' duly signed must be uploaded while submitting the e-bid. Tenders received without the 'Bid Security Declaration' will be rejected (except in the case of NSIC/MSEs registered bidders).
