- vii. Earnest Money Deposit (EMD)/ Bid Security Declaration: The bidder must submit a 'Bid Security Declaration' declaring disqualification/suspension of his bid in case the bid is withdrawn or modified by him during the bid validity period. The format of 'Bid Security Declaration' is available in the Tender Document. 'Bid Security Declaration' duly signed must be uploaded while submitting the e-bid. Tenders received without the 'Bid Security Declaration' will be rejected (except in the case of NSIC/MSEs registered bidders)..

Note: The Micro and Small enterprises (MSEs) and the firms registered with National Small Industries Corporation (NSIC)/ Small Scale Industries (SSI)/Udyam Aadhar Registration etc. are exempted from submitting the Bid Security as per prevailing rules.
